## 2019 New Member Deferred Payment Promotion

Well in response, Wedgwood Country Club is now offering to potential new members, an alternative to this age old problem.

From now until March 1, you can join Wedgwood Country Club without the need to pay for your Membership for up to four months.

### Our Offer:

Join one of Wedgwood CC **Greens Fee Discount Plans** (GFDP) on or before March 1, 2019, and receive **No Pay Until May** payment terms!

New Member's will receive The GFDP (of their choosing) and its privileges, without the need to pay membership fees or greens fees associated with their plan, up front.\*

If Membership is right for you, pay your GFDP by May 1, 2019 and enjoy the balance of the 2019 season as a member in "good standing" of our club. If membership is not right for you, just notify the club of your decision to terminate, pay for the rounds you played to date at applicable Greens fee rates, and terminate with no other obligations.

### Requirements/Responsibilities:

- Offer extends to new members only.
- Prospective member must complete the Wedgwood CC Greens Fee Discount Plan Application.
- Prospective member must complete the Wedgwood CC Deferred Billing Agreement.
- Prospective member must pay a \$75.00 administrative Sign-up Fee upon sign-up.
- Member must keep a current authorized credit card on file with Wedgwood CC.
- Once accepted, members choosing to remain members must pay their membership amount in full by May 1, 2019 by check, cash, or credit card on file.\*\* Those members choosing to leave on or before the March 1<sup>st</sup> payment date must pay for the rounds they have played to date for that year, at the applicable greens fee rates prior to termination.

\* All other fees and charges related to play or other membership benefits are due at time of purchase.

\*\* Other rules/restrictions related to membership plan may apply.



**Wedgwood Country Club Deferred Payment Promotion Agreement**

It is acknowledged by me, \_\_\_\_\_, (the plan holder), that on this date \_\_\_\_\_

(Plan Start Date), I have agreed to be bound by the Wedgwood Country Club (WCC) Deferred Payment Promotion Agreement. I understand and agree that I will be responsible to pay for my Greens Fee Discount Plan (GFDP) in one (1) lump sum payment that is due and owing on May 1 of the actual discount plan year which I am in, or, if I choose to terminate my membership, I agree to pay for the rounds I have played to date at the applicable greens fee rates, in full, at time of my termination, and I authorize WCC to charge my credit card on file to pay for those charges unless I have made other arrangements acceptable to the club, with the club.

I understand and agree that the GFDP dues amount for a \_\_\_\_\_ plan (the GFDP of my choosing) is \$\_\_\_\_\_ dollars per year, and I agree to pay this amount, in full, as outlined above regardless of my ability to use the plan, or my standing in the club at any time.

I further understand and agree that in the event WCC is unable to collect any outstanding monies owed by me related to this agreement, that in accordance with this agreement, WCC may:

- Suspend and/or terminate my GFDP privileges.
- Use any and all means necessary to collect all past, present, and future dues amounts owed under this agreement.
- Recover from me any collection fees, bank fees, court costs, and reasonable attorney’s fees WCC may incur do to their collection efforts
- Agree that any dispute arising from this agreement shall be governed by the laws of the State of New Jersey, and I consent to the Jurisdiction of the New Jersey courts.

This agreement constitutes the entire agreement between the parties. Any promises, representations, understandings, oral or written pertaining directly or indirectly to this Agreement which is not contained herein, are hereby waived.

I/We hereby accept and agree to be bound by the terms of the GFDP Application and this agreement.
