Wedgwood Country Club's "E-Z-Play" Discount Plan Agreement

By completing and signing this E-Z-Play application and depositing the sum of Seven Hundred and Fifty dollars (\$750.00) (the baseline credit amount) with Wedgwood Country Club (WCC), I understand and agree that I have joined WCC as a E-Z-Play Pass Holder, and established an initial line of credit with WCC to be used as outlined below. I further understand and agree that this credit amount is not a fixed line of credit, but a floating credit amount that I have at my disposal and that my Plan credit balance will fluctuate up or down based on my usage and charges against it and my ability to replenish it as needed.

My Credit amount may be used in the following manor throughout the course of the year:

- I may charge greens fees (My fees as well as guest fees) against my credit and receive a \$10.00 discount off regular rack rates for each round played (this offer may not be combined with any other discounts).
- I may charge cart fees (My fees as well as guest fees) against my credit and receive a 10% discount off regular rack rate cart rates.
- I may charge pro shop food and beverage and other merchandise (Balls, Gloves, Tee's, etc., "hard goods" not included) against my credit at a 10% discounted rate.
- I may pay for club handicap serves fees with my credit.

E-Z-Play Discount Plan Limitations, suspension, and replenishment policies are as follows:

- I may not use my Credit to charge any Food or Beverage items at Divot's Lounge or against any on-course food or beverage purchases made at the club.
- I may not use my Credit for any "hard goods" sold in the pro shop or for any non-club related fees that I may incur other than those listed above.
- Once I have exhausted my Plan credit, any new or current unpaid charges with a remaining balance that might exist must be paid by cash or credit/debit card at time of transaction.
- I will have the option of adding additional dollars (in no less than \$200.00 increments) to my E-Z-Play Plan account at any time during the life of my Plan, or when my account credit has been exhausted.
- If I choose not to add additional dollars to my account when exhausted, I understand that my Plan shall be suspended until such time as I have added additional dollars to my account. During the suspension period, I may still play at the club, but I will no longer receive discounts related to greens fees, cart fees, food and beverage or merchandise.
- Once I have re-established credit with the club, my privileges shall be reinstated.

E-Z-Play Discount Plan Credit Balance and future year's Plan Status:

- If I end the year with a credit balance on my account, my credit will be carried forward and added to my upcoming year's credit line.
- In order for me to receive all the benefits associated with membership and to be considered a "Plan Holder in good standing" for the following year, I will need to re-establish my baseline credit amount for that new year by the first of the year. Once my baseline credit has been re-established, my previous year's credit shall be applied and I will receive all the benefits of a Plan Holder as outlined above.
- If I choose not to renew my E-Z-Play Plan for the following year, I will be able to use the remaining credit balance on my account, but all amounts charged against the credit shall be at current rack rates. No discounts of any kind will be afforded me.
- I understand and agree that any remaining balance on my account may not be redeemed for cash or other monetary instrument and that I have twelve (12) months from the expiration of my previous year's Plan end date to redeem my un-used credit. Any unused balance that remains after the twelve (12) months shall be forfeited.
